Related areas of research include topics in Astrophysics, Particle Physics, Condensed Matter Physics and Many-Body Theory, Methods of Field Theory, Physics of Ultra-Cold Atomic Gases, Machine Learning and Quantum Information/Technology .

The Scientific Board encourages Organizing Committees to consist of a combination of Established and Early-Career researchers.
